Student Residency Verification

Should the District determine that a student is not a resident of the Beach School District or does not meet the above definition of homeless, the Beach School District shall notify the school district of residence and the student's parent/guardian and withdrawal from Beach Public Schools (unless an exception under the McKinney Vento Homeless Education Act applies).

Upon receiving notice of withdrawal from the District, student must immediately enroll in their district residence. Under North Dakota law, the district of residence is obligated to comply with the compulsory attendance violations to the local law enforcement agency.
